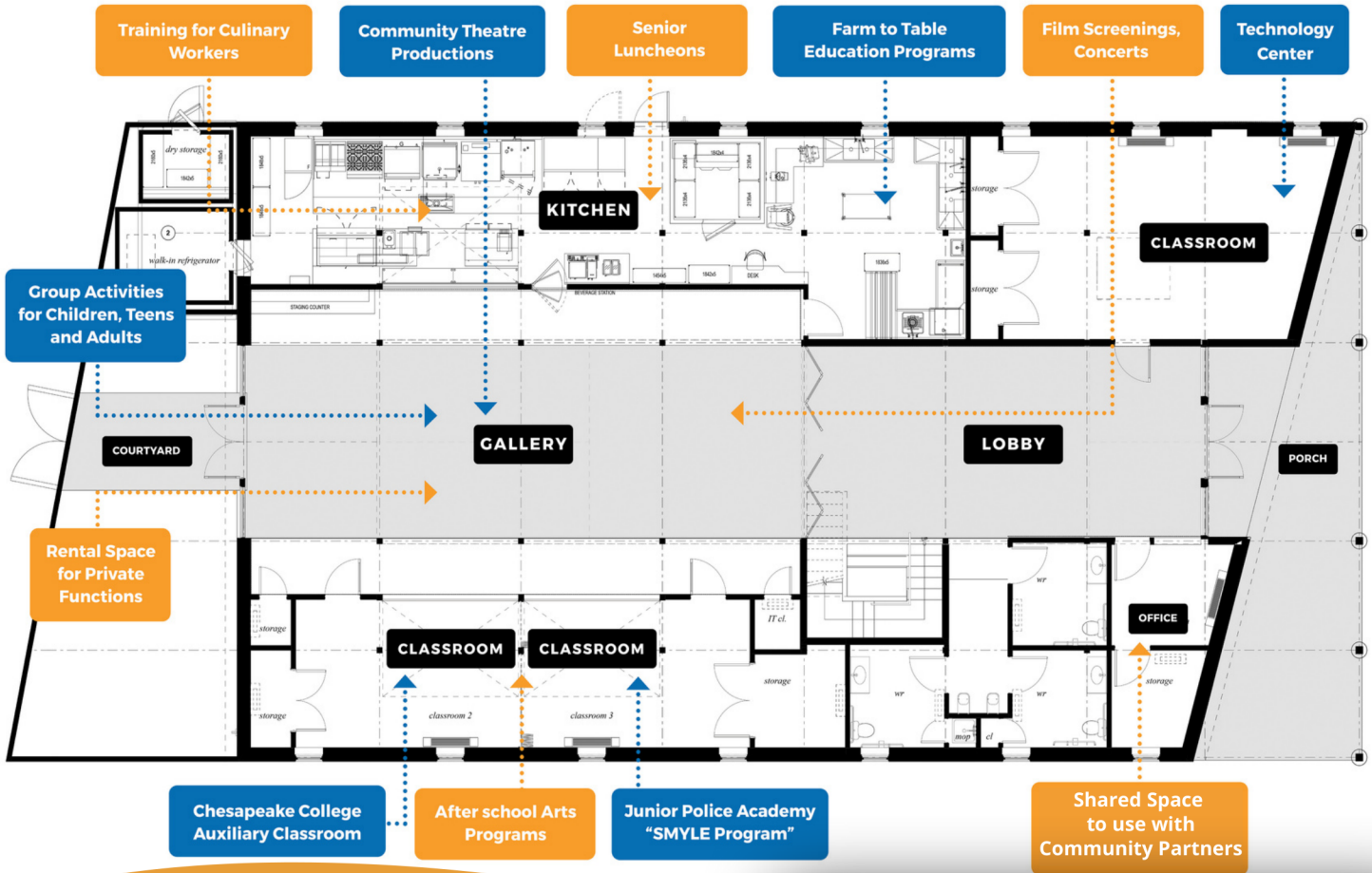

## THE NEED: A PLACE TO LEARN, CONNECT & GROW

The St. Michaels Community Center's total renovation of our aged building will include modern, equipped classrooms for after-school programs, summer camps, and adult education, along with a Technology Center to provide online classes offered by Chesapeake College and a home for a retail entrepreneurship training program.

The renovated center also will help to expand community food distribution services, including a modern commercial kitchen for a new Culinary Arts & Hospitality Workforce Development Program.

*The building renovations began in late 2022 and are on schedule to be completed by the end of 2023.*
